The theme of the 2018 CIBHS EVIDENCE-BASED PRACTICES SYMPOSIUM is "**BUILDING LIVES BEYOND TRAUMA**". This is a theme that inspires hope that despite significant and complex traumas, living a happy, healthy, meaningful life is possible. This year's Eighth Annual **EVIDENCE-BASED PRACTICES SYMPOSIUM** focuses on the reality that, with implementation of practices designed to support the journey beyond trauma and the label of mental illness, there is a full life.

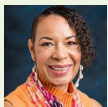
